Support for People with Developmental/ Intellectual Disabilities

Unity House works with adults to enhance their skills in the home and the community, and to foster self-esteem, productivity, and a high quality of life. Services include:

- Day & Community Habilitation
 - Full or half day services available
 - Individual and group settings

Residential

- A variety of housing solutions range from 24/7 supervised sites to supportive sites with occasional staff assistance
- Respite care is available on a planned or emergency basis with 24-hour supervision

Support for Adults in Recovery from Substance Use Disorder

Unity House offers two residential options in Auburn, NY for people recovering from addiction disorders:

GRACE House

- Recovery residence for men and women based on 12-Step programs
- Continuous support focusing on individualized recovery plans, including treatment for alcoholism and other drug addictions, trauma-informed care, group therapy, and self-care classes

Supported Living Residential Reintegration

- Apartment setting, with separate program tailored to residents who are pregnant and/or have children
- Case management services include pre-vocational training, employment preparation, volunteer work, parenting classes, mental health services, and treatment for alcoholism and other drug addictions

Support for Adults with Mental Illness

Unity House partners with people with mental illness to help them recover. Our support helps them gain the skills, knowledge, and resources necessary to achieve independence and self-sufficiency. We offer:

PROSperity Program

- An environment that fosters the recovery skills needed for people to live their lives more fully
- Certified Treatment Apartments
 - This licensed temporary housing option offers ongoing support to those who can benefit from daily assistance
- Permanent Supportive Housing
 - Safe, affordable living options coupled with individual support services
- Forensic Supportive Housing
 - Supportive apartment programs for people who are exiting the forensic system and for those with co-occurring mental illness/substance use disorder
- Employment
 - Prepares and trains people for competitive, productive work
- CORE Services
 - Provides opportunities for Medicaid beneficiaries to receive services in their own home or community
 - Ensures full access to the benefits of community living and that those benefits are offered in the most integrated settings

Respite

- Available on a planned or emergency basis with 24-hour supervision
