## Andrew Cuddy steps down as **Board President**

After serving 14 years on Unity House's Board of Directors, including four years as its president, Andy Cuddy stepped down in May.

"It has been a great joy to work with my fellow board members, the administrative team and the Unity House staff in accomplishing a difficult mission over these many years with, what I believe, has been great



success," Andy said in his resignation letter to the board. "I have taken pride in playing a small role in the mission of Unity House."

Andy has been a consistent donor and strong advocate for expanding Unity House's fundraising efforts. He pushed especially for an endowment fund to ensure that the organization can continue delivering on its mission for generations to come. During his tenure, Unity House established an endowment that has grown to more than \$500,000.

Unity House CEO Liz Smith said Andy has been an asset to the organization since he joined the board in 2010, shortly after she became its chief executive. As board president, Andy supported Liz through difficult decisions brought on by the COVID pandemic, she said.

"Andy is an effective leader because he asks a lot of questions and he has a lot of ideas," Liz said. "He has been engaged, and he has been generous to Unity House in so many ways. I'm sad to see him go. I wish him well."



Keynote speaker Charlie Mills shared his poignant story, how he became addicted to drugs in his teens and went through numerous treatment programs before he came to Unity House's GRACE House a dozen years ago. His construction business, Mr. Mills Enterprises Inc., is now well-established and in high demand in the area.

Another highlight of the evening was the award ceremony. Elaine Meyers of King Ferry received the 13th Open Arms Award. A local author and lifelong lover

## COOKING WITH CONFIDENCE



Jeffrey Schmitz loves the equipment, the heat and the team hustle of working in a professional kitchen.

As a participant in Unity Employment Services, he had tried many jobs. But even though his favorite jobs were in food service, he hadn't worked in a kitchen since he had a bad experience a few years ago.

Then, Jeffrey began a class through UES's new Career-Specific Vocational Training program.

"The best part is when someone says, 'Jeff, you did a good job today,'" Jeffrey said. "I'm glad when I hear that."

"He was hesitant at first, but I could tell he had an itch for food service," said Vocational Services Coordinator Steven Hurst. "He ended up being just a wonderful fit for the class."

As Jeffrey gained new skills in food prep and kitchen management, he also gained confidence, Steven said. Jeffrey even bought his own French chef knife so he could practice his cutting skills outside of class time.

After graduating from the training program, Jeffrey began an internship through the state Office for People with Developmental Disabilities. The state pays Jeffrey's wages for up to 12 hours a week over 12 weeks, with Steven as his on-site job coach. In May, Jeffrey started working as a line cook at the Holiday Inn in Auburn, and he has been flourishing, said UES Director Amanda McManus.


"He's cooking the food, he's prepping, he's plating," she said. "He's rotating stock and keeping the kitchen in order."

Holiday Inn Food and Beverage Manager Mindy Sheftic said she wishes all of her workers were like Jeffrey.

"He's always happy to be here and he takes a lot of pride in what he does," Mindy said. "His presentation of the food is better than my regular line cook, to be honest."

Mindy said she hopes Jeffrey can stay on after the internship concludes. Jeffrey said he'd like that a lot.

## **GRANTS & GIFTS**

Unity House is deeply grateful to receive grant funding from:

#### **Tompkins Charitable Gift Fund - \$3,230**

To purchase a smart whiteboard and a Bluetooth projector for use in learning classrooms for people with developmental disabilities. This technology has now been installed at our day habilitation location in Ithaca.

## New York State funding through Sen. Rachel May's office - \$120,000

To improve accessibility in Cayuga County. The grant will allow us to renovate the front entrance of our North Street Road IRA, remodel a restroom at our GRACE House, and install a ceiling track lift system at our Auburn Day Hab.

## New York State funding through the Dormitory Authority - \$499,870

To improve safety, accessibility, and structural integrity at our West Green Street IRA in Ithaca. Its 12 residents will gain more autonomy with a new entrance ramp, accessible bathrooms, expanded and upgraded living space, and more accessible kitchens.

Unity House has reached out to a number of regional funders for help in offsetting the costs associated with purchasing and installing a **new networked organization-wide phone system** across seven counties. The total project cost is \$78,000 for 150+ smart telephones. To date, the following community partners have supported this important need:
