HEALTHY FOOD, SOUND SLEEP AND SOCIAL CONNECTION ARE BASIC NEEDS THAT MUST BE MET FOR PEOPLE TO THRIVE. THAT'S WHY WE PROVIDE RESIDENTIAL SERVICES TO PEOPLE WITH INTELLECTUAL AND DEVELOPMENTAL DISABILITIES, PEOPLE RECOVERING FROM MENTAL ILLNESS, AND PEOPLE RECOVERING FROM SUBSTANCE USE DISORDER. EACH PERSON'S INDIVIDUALIZED RESIDENTIAL PLAN IS DESIGNED TO MAXIMIZE THEIR AUTONOMY WHILE ENSURING THAT THEY GET THE SUPPORT THEY NEED TO THRIVE. STAFF HELP RESIDENTS GAIN LIFE SKILLS, STRENGTHEN RELATIONSHIPS, MAINTAIN HEALTH, STAY SAFE AND PARTICIPATE IN ACTIVITIES THAT IMPROVE THEIR WELLBEING. THOSE WITH THE GREATEST NEEDS MAY LIVE IN A CONGREGATE RESIDENCE WITH SUPPORT STAFF ON SITE 24 HOURS A DAY, SEVEN DAYS A WEEK.
